# **Policy**

On an annual basis the Council of the City of Port Moody provides Commemorative actions through their declaration of days of recognition, in accordance with section 157 of the *Community Charter*. Historically, the City would provide written documents and formal resolutions of support through Proclamation Requests. However, as the City evolved increasing forms of Commemorative acts have been requested to Council, including Lighting Requests.

As the City moves away from historical colonial practices, Proclamation Requests are no longer accepted in lieu of other forms of commemoration. One form of commemoration that is sustained and increasing in distinction is through the lighting of City Hall's exterior. Staff have previously established a Commemorative Calendar where the illumination of City Hall observes dates of significance through changing of specified colours for a pre-determined period. An annual Commemorative Calendar detailing the subject matter, dates, and colours is attached to this Policy as Appendix A.

As City Hall lighting has become a growing beacon of commemoration, Lighting Requests from individuals or organizations have been submitted for inclusion on the Commemorative Calendar. This Policy serves to address public Commemorative Lighting Requests and provides Council and staff guiding principles, criteria, and process for requests. Unless directed by the Mayor or Council, approved Commemorative Lighting Requests will be added to the Commemorative Calendar for the remainder of the Council term of the day.

This Policy supports the City's strategic and corporate plan goals toward ensuring the City is providing core service delivery and supporting a vibrant community by upholding the freedoms and rights of all community members through the provision of a non-partisan, non-denominational, non-discriminatory, reconciliation-based, and equitable approach to Commemorative Lighting Requests.

## **Definitions**

"Commemorative" is a term applied to a subject matter intended to honour, remember, or amplify awareness of significant events, dates, or initiatives in effort to recognize and celebrate the importance of the subject matter within the community.

"Proclamation Request" is a formal request in writing made to Council for an official public resolution and/or statement regarding a specific subject matter, usually formalized in a signed and/or certified document to commemorate events, significant dates, or initiatives by declaring its significance across the land and territory under the jurisdictional boundaries of the Council of the City of Port Moody.

"Lighting Request" is a formal request in writing made to Council for an official declaration of support regarding a specific subject matter through illumination of City Hall with a specific series of colors for a specific time.

Commemorative Lighting Requests

# Scope

This Policy applies to all written requests to Council or the City of Port Moody, including Lighting Requests, Proclamation Requests, and other requests that fall within the eligibility criteria.

For clarity purposes, Proclamation Requests are not accepted and not issued by the City of Port Moody, and this Policy does not apply to any requests regarding flags, memorial services, or other government protocols. If the City of Port Moody has existing bylaws or policies addressing the non-defined Commemorative Lighting Requests, the bylaw shall prevail, and policy direction shall be at the direction of Council.

### **Procedures**

From time to time, Council receives requests from individuals and/or organizations seeking commemoration for events, dates, and initiatives of significance to increase awareness and education to the community. The following policy guidelines detail the submission, eligibility criteria, and exemptions for receiving, processing, and approving Commemorative Lighting Requests.

### Commemorative Lighting Request Submission:

All Commemorative Lighting Requests must meet the following eligibility criteria in their submission:

- be delivered to the Corporate Officer in writing (via email, letter, or website form) a minimum of 15 business days prior to the first day intended for the Commemorative period to allow for a Regular Council meeting to be held for the consideration of the request;
- must include background information regarding the requesting organization, including but not limited to:
  - name and title of representative;
  - contact email and phone of representative and/or organization;
  - physical address or a business licence of organization that falls within the Metro Vancouver Regional District jurisdictional boundaries;
  - organization date of incorporation or creation; and
  - organization type (charity, not-for-profit, corporation, crown corporation); and
- must include background information about the requested commemoration, including but not limited to:
  - purpose of request that includes a local component within Port Moody or the Metro Vancouver Regional District;
  - dates and times of commemoration;
  - location of request;
  - specific actions Council or City staff are being requested to take;
  - the requested/desired lighting colour schemes; and
  - if regarding a future event, details on the required actions or costs to the public to allow participation or attendance.

Commemorative Lighting Requests

### **Council Approval Process:**

The Corporate Officer or their designate will receive all Commemorative Lighting Requests and determine eligibility. Once the request has been deemed eligible, the Corporate Officer or their designate will provide it to Council for consideration on the next available Regular Council agenda, in accordance with the Council Procedure Bylaw and Annual Council Meeting Calendar.

Requests received during periods when no Council meeting is scheduled prior to the requested date may be considered for approval by the City Manager.

Late requests for inclusion on Council meeting agendas are subject to the approval of the Corporate Officer or their designate, in accordance with the Council Procedure Bylaw.

### **Health Related Lighting Requests:**

Requests for Commemorative lighting to raise awareness about health-related issues will be considered for approval by the City Manager or their designate. Requests that have been approved will be placed on the next available Regular Council agenda for information.

#### Lighting Requests for Extended Periods:

If a Lighting Request is for an extended period (e.g., a week or a month), staff will program the City Hall illumination system to light up on the first available date during that period only, not for the entire period.

#### Annual Lighting Calendar

The annual Lighting Calendar is currently classified in the following subject matters:

- Social Issue/Celebration;
- Indigenous/Reconciliation;
- Cultural/Celebration;
- Environmental; and
- Memorial.

New additions to the annual Lighting Calendar can only be submitted once per elected Council term (four-year terms) and, once approved, will remain on the annual Lighting Calendar until that Council term ends. The current annual Lighting Calendar at the time of this Policy's adoption, is included as Appendix 1. At any time, Council can remove or suspend a previously approved subject matter from the annual Lighting Calendar.

#### Evaluation and Eligibility Criteria:

Any Commemorative Lighting Request considered to fall into one or more of the following categories will not be accepted by the Corporate Officer:

- requests for dates that have already passed in the same calendar year;
- requests for dates that are more than six months in the future;
- requests from faith-based groups or political parties, political candidates, and/or subject matter deemed political in nature;

- any racist, illegal, discriminatory points of view or any criteria determined to violate the equality rights of the *Canadian Charter of Rights and Freedoms*;
- promotion to directly encourage, or exhibit obvious indifference to unlawful behaviour;
- campaigns, lobbying, or events contrary to City policies or bylaws;
- individual recognition or personal occasions (e.g. birthdays, anniversaries, etc.);
- commercial interests and/or activities (e.g. product launches, corporate events, etc.);
- subjects pertaining to polarizing events that divide, rather than unite, the community; and
- requests for dates that conflict with dates or subject matters already on the annual Lighting Calendar.

The Corporate Officer will place Lighting Requests on the next available Regular Council meeting agenda for Council consideration under "Other Business". Following Council consideration:

- Legislative Services Division staff will contact the requestor to inform them of Council's decision.
- Cultural Services Division staff will program the City Hall illumination system and post a link to information about the event on the City website.

Even if approved in previous years, or accepted by the Corporate Officer, requests cannot be assumed approved until Council exercises this authority.

# Monitoring/Authority

This Policy is to be administered and monitored by the Legislative Services Division and the Cultural Services Division, in consultation with the City Manager's office.
