Consideration will be given to holding the meeting closed to the public pursuant to the following sections of the <i>Community Charter</i> : <ul style="list-style-type: none">• 90(1)(a) – personal information about an identifiable individual who holds or is being considered for a position as an officer, employee, or agent of the municipality or another position appointed by the municipality;• 90(1)(c) – labour relations or other employee relations;• 90(1)(d) – the security of the property of the municipality;• 90(1)(e) – the acquisition, disposition, or expropriation of land or improvements, if the council considers that disclosure could reasonably be expected to harm the interests of the municipality;• 90(1)(i) – the receipt of advice that is subject to solicitor-client privilege, including communications necessary for that purpose;• 90(1)(k) – negotiations and related discussions respecting the proposed provision of a municipal service that are at their preliminary stages and that, in the view of the council, could reasonably be expected to harm the interests of the municipality if they were held in public; and• 90(2)(b) – the consideration of information received and held in confidence relating to negotiations between the municipality and a provincial government or the federal government or both, or between a provincial government or the federal government or both and a third party.


